Electrical Safety

If you are replacing your wood or propane fireplace with an electric one, please make sure you are using a licensed electrician, not a handyman. Without a separate circuit you will be unhappy with your results in spite of your significant investment.

And if you are going to be installing lights for the holidays, please check that wiring to ensure it is not frayed.

Deadline for ACR submissions to be considered

The Board voted to reinstate a deadline to have ACRs considered. Fully completed ACRs must be submitted to the Office by the Wednesday prior to the Monday Covenants Committee meeting, apart from emergencies such as HVAC replacement.

Unit Maintenance Requirements for 2026

- We will continue to require
 - 1. annual dryer vent cleaning and
 - 2. annual spring HVAC servicing, including condensate cleaning
- If you have already provided proof of plumbing inspection and chimney/fireplace inspections, these will not be required in 2026. However, the Board reserves the right to reinstate these requirements if we see a resurgence of plumbing leaks/fireplace issues.
- For owners who have not provided documentation of plumbing, chimney/fireplace, or sprinkler inspections, or the repairs noted in those inspections, we will proceed with the violation/fining process.

Update on pool deck renovation

You may have noticed piles of fresh lumber deposited on the edge of the clubhouse parking lot by the Chester River. It will all be used for the rebuilding of the aging pool deck. Preliminary work has begun on the project with the repair and weather protection of the existing wooden wall (pool bulkhead), which is mostly tucked under the decking. As work progresses the entire deck structure will be torn out and a new very long lasting deck substructure and deck will be built. A new lighter color deck has been chosen to keep the deck somewhat cooler on hot days. This project is the result of years of financial and project planning, and is fully funded by our Reserve account. Stay tuned for more progress reports from the Long Range Vision and Planning Committee as we proceed.
