### Comcast Installation Update

Snow on the ground will delay some of these preparations, but Comcast did build weather considerations into their scheduling. You will see paint and flag markers around the campus as Comcast begins the installation of their access equipment. After establishing the best routes to avoid existing

underground cables and drainage lines then the trenching team will follow. The next steps will be splicing, testing, then activation. Comcast expects this phase to be complete in early April. Then they will begin marketing to unit owners. Please remember, no unit owner is obliged to sign up with Comcast. This is simply an available service.

## 2026 Unit Maintenance Requirements

- Queen's Landing will continue to require
  1. annual dryer vent cleaning, and
  2. annual spring HVAC servicing (between March and May 2026).

January's Board Meeting was held January 26, at 7:00 pm. Many thanks to the community members who joined us in person and virtually! A lot was done to move the community forward. Due to icy conditions, the meeting was held virtually. Highlights from the meeting:

### **ICE, ICE, AND MORE ICE....COLD, COLD, AND MORE COLD.....**

What a week. We got the triple whammy of a streak of subfreezing weather, snow, and a thick cover of ice. This made snow and ice removal much more difficult than what is typical.

The Board appreciates your frustration as well as your patience, and a special thank you to everyone who showed grace and compassion by helping neighbors where they could and letting Chester River get on with their work without interruption. A shout out too, to one of our brand-new Board members, **John Lancey**, who chairs the Maintenance Committee, and Landscape Chair, **Tracey Weaver**, who worked tirelessly through the storm and its aftermath to strategize with Chester River to clear this mess as efficiently as possible.

John would love to have more volunteers for the Maintenance Committee—please, raise your hand and help find solutions for your community!

### **TIME TO PARTY!**

Messy, subfreezing weather does not get in the way of your intrepid Social Committee! They've organized not one—but **TWO Super Bowl Parties for February 8!** The main event will be in the Chester Room (upstairs), with the game on, a chili cookoff, and the chance to win some prizes and cash! ### **FINANCIALS**

While the final 2025 numbers are not in yet, it looks like Queen's Landing will realize a moderate loss. This is due to water damage and plumbing repairs, grading and drainage issues, snow and trash removal, and concrete repairs. Auditors start their review of the 2025 financials in March.

### **COMCAST**

Comcast continues their work on installing infrastructure, as weather allows. You will probably start hearing from them in April about their services. Remember, this is an added available service option; no resident is under any obligation to sign up with them.

### **MARINA EXECUTIVE COMMITTEE UPDATE**

A Marina Reserve Study has been completed, the first step in developing a plan for long-delayed repair of the bulkhead and piers. It's a big project, and won't be cheap. About half the cost – for the bulkhead – will be incurred in the next four years. The balance for the piers and docks does not need to be completed until 2039. The Marina Executive Committee and a task force set up by the MEC are methodically tackling the various options for how to fund the repairs. This is an important project, not only to the marina but to the community as a whole.

Committees are the real engine that move Queen's Landing. They solve problems and find solutions. Thanks to all Committee members and chairs for the hard work they do for all of us.
